- Provide comprehensive training for IME examiners on ethical standards and methodological rigor to improve the quality of assessments.
- Utilize standardized psychiatric rating scales and screening tests with embedded validity parameters to ensure objective assessments.

• Promote the dissemination of updated best practices and standards to improve competence among IME providers.
